Should any trees be mistakenly identified as to ownership, the customer agrees to compensate CLIFF SIDE TREE SERVICE for any cost or damages incurred as a result thereof.
- \*In the event there is any change in the condition of the tree(s) or physical surroundings of the job site from the time of inspection to the time of job performance, which would cause additional labor to accomplish the work, CLIFF SIDE TREE SERVICE may, at its option, adjust the contract price to reflect the increased cost.
- \*The customer agrees to provide CLIFF SIDE TREE SERVICE the exclusive use of the entire job site, including unobstructed access areas, during the performance of the outlined work.
- \*CLIFF SIDE TREE SERVICE will attempt to minimize disturbance to the customer's lawn. The customer understands that unless specifically provided herein, any lawn, irrigation or utilities repairs are not included in the contract price.
- \*CLIFF SIDE TREE SERVICE cannot be held liable for the health of trees, property damage or injury to persons, after completion of contract.
- \*Should default of payment result in legal action, all cost of collection, including attorney's fees, shall become a proper charge hereto.
